

# August 2016 Newsletter Towards equality in local government

NCW Victoria's partnership with the Australian Local Government Women's Association (ALGWA) Victoria in the annual *My Vote My Voice* program for school students at the Parliament of Victoria has its origin in a report on Intergenerational Issues prepared by Cr Coral Ross after her return from a trip to Canada.

ALGWA runs a nationally accredited program called the **5050 vision for gender equality.** Cr Coral Ross now, National President, Australian Local Government Women's Association says ... the program is designed to encourage Australian councils to improve gender equity both within the organisation and among the elected representatives. It can be accessed by all councils, regardless of their size, location or progress on gender equity. Councils from across Australia have registered for the program, which have three levels: bronze, silver and gold.

Councils needed to do a number of things to achieve the Gender Equity Awards. These included a commitment in the corporate policy; policies and strategies to demonstrate commitment, plus actions, and a project which has addressed gender equity issues. Councils also needed to supply gender ratios, which will provide an up-to-date picture of local government. The entire program is strongly based on resource sharing and networking. Last year at our State of the Nation" conference in Barossa, a number of councils showcased the projects they had implemented. Among the featured councils were Devonport City Council in Tasmania; Broken Hill City Council in NSW; Central Highlands Regional Council in Queensland; City of Ryde in Sydney; Holroyd City Council in South Australia and Darwin City Council in the Northern Territory. The contract with LGAQ, who were the 5050 project coordinators, finished in December. Last year the ALGWA Board agreed to take over the program and are in the process of finalising the changeover.

Today 31.58% of Australian councillors are women. NSW has the lowest percentage of female councillors at 27%. Leading the country is the Northern Territory with 36%, closely followed by Victoria on 34%. In March, Queensland moved into third place with 32.5%, Western Australia is just behind on 31.6%, Tasmania is at 31% and South Australia is the only other state below 30% with 29%. Those States which have a higher proportion of women councillors in turn have a higher number of female Mayors and female CEOs/General Managers.

Our data proves having women at the table makes a difference in selecting a woman. Last year in Victoria 35% of Mayors were women, 34% in the Northern Territory compared to 19% in NSW. More than a quarter of the CEOs/General

<u>NCW New South Wales</u> - The 120<sup>th</sup> Foundation Day Luncheon, on 8 August, commemorates first NCW meeting held in this country. Premier Mike Baird and the Minister for Women Pru Goward will be in attendance. Six women will receive Recognition Awards, the Hon. Elizabeth Evatt AC will launch a biography of Marie Byles first woman qualified to practise law in NSW and the Guest Speaker is Dr Lisa Murray, Historian at Sydney City Council.

NCW Tasmania - Following the closure of NCW Launceston, steps are being taken to dissolve NCW CTI.

<u>NCW Western Australia</u> - New office bearers are President - Mrs. Robyn Nolan, 1<sup>st</sup> Vice President- Ms Marion Ward, 2<sup>nd</sup> Vice President - Dr Dawn Butterworth AO, Secretary - Mrs. Helen McDonagh, Treasurer- Mrs. Sally Warner, Coordinator of Standing Committees - Mrs. Jan Rose and Communication Officer - Mrs. Merrill Cole. # Where are the women? Follow-up from Jenny Standish's presentation on the Australian Honours system.

The Pink Sheet Exercise segment of the meeting raised a number of issues:

Q: In relation to the idea to start by locating or creating a profile of the person, surely some occupations and activities have more easily accessible information? What if the person has been mostly involved in community or religious activities without having had extensive formal education? Or who has made a contribution to a particular cultural group? A: Relevant information in a nomination - all or any that illustrates the contribution to society of the individual, this may be mainly religious activities for any faith, or for multicultural or single cultural activities, educational level can be mentioned but is not essential.

**Q: Do you need a nominee's consent?** – A: This differs from award to award. For some awards the form needs to supply next of kin information and the consent (signature) of the person nominated. Where the nomination is for an Australian Honour, a Case Officer, working in the Australian Honours and Awards Secretariat, Office of the Official Secretary to the Governor-General, Government House, Canberra ACT 2600 writes to referees. At this stage the nominee should not know of the nomination and so her signature is not required. It is essential that the person making the nomination signs. Then once referees reply positively and the award is to go forward, the nominee receives a letter from the Honours Secretariat informing them of this, together with an acceptance form.

Q: Why do men who are the suggested referees fail to respond when the Honours Secretariat writes asking for a comment about the work done by the woman? A: Even if in some cultures it seems men will not allow women to be nominated, it is a good idea for nominators to thinking about the selection of men and women as referees who could be expected to be sympathetic to recognition of the person's contribution. An Affiliate Group may be well positioned to nominate, but sometimes it might be an external community group or member who appreciate the woman's contribution. Nominees must be willing to keep confidence. A person who agrees to assist with a nomination for an Australian Honour is asked not to disclose to others including the nominee that the process has begun.

**Q:** Why are some women reluctant to accept the nomination or to be nominators or referees for other women? A: The point needs to be made that women should accept nominations so that women are better represented. An award is recognition for all women particularly the members of the groups to which the nominee belongs.

Jenny Standish reminded us "While there are several avenues for recognizing the contribution a person has made to our society, the talk on July 7<sup>th</sup> focused on the Australian honours and how we can help to raise the number of women on that list. The specific requirements for nominating an Australian citizen for an Australian honour are readily available on the internet:

**Child and Families Standing Committee (**Anne McLeish OAM Director Grand Parents Victoria /Kinship Care Victoria) -In 2010 KCV established a longitudinal study into the lives of 113 kinship carer families. Each year the carers share news about their lives and the lives of the children/young people for whom they care. This article provides extracts from the 2016 KCV Longitudinal Study.

The outcomes of the study inform both the work program of KCV and discussions with a range of decision makers who have the authority to make decisions that affect the lives of kinship carer families. In 2011 the study commenced with 177 children/young people in care being cared for by 113 kinship care families. Since that time, 18 new children have been placed with the already surveyed kinship carer families, bringing the total number of children/young people who have entered the study to 195. This report outlines the movements and outcomes of these children/young people and the circumstances of the carers – all of whom are committed to their role and would do the same thing over again.

**Carer happiness is linked to outcomes** - The wellbeing of the children and young people is directly linked to the way the carers feel about their role with their personal happiness being entwined with the wellbeing of the children they are raising. The 47 families still caring for children/young people in 2016 reported, when considering their role, that:20 have positive feelings, 25 have mixed feelings, 2 have negative feelings about the wellbeing of the children. Those who reported mixed feelings were still more positive than negative and were cautious in their response because *things are up and down*.

Even those carers who reported feeling positive still faced challenges, particularly relating to the financial pressures of feeding, clothing, educating and providing healthcare for the children/young people. Also, health problems associated with old age are increasingly becoming a concern for some, as are succession plans in the case that something happens to the carers before the children turn 18. Small numbers of carers are crafting their own "succession plans" for the care of the children and seeking court approval, a move that has been welcomed by the courts. This is an issue that could be addressed at an initial family conference held at the commencement of the placement.

Given the stresses attached to their role and current public discourse about adoption, the carers were asked how they felt about this option. They were adamant that they did not want children adopted away from the biological family whilst there is any relative willing and able to raise the children. Two trends in unexpected numbers - KCV expected that some carers would take on the care of new children and that others would leave kinship care to be reunited with their parents. However, the numbers involved in both these trends are surprising with 18 new children entering the study and 24 being reunited with their parent/s. Both movements in and out have been taken in the best interests of the child.

Children reconciled with parents - Over the length of the study 24 children have been reconciled with parent/s:

- 13 of the children are in reconciliations that proceeded smoothly and are stable.
- 7 children are in reconciliations that did not proceed quite so smoothly.
- 4 children are in reconciliations about which there is no current information, but which are ongoing. The lack of detailed information arises from the fact that the carers who resisted the reconciliation in the first place were unwilling/unable to speak about how it was proceeding.

It is also known that:19 children remain with one of their parents (for 3 children, this is not the same parent with whom they were originally reconciled), 3 are known to have turned 18 since reconciling with their parents; One young person is now living in a youth hostel; The whereabouts of one young person is unknown

KCV did not expect the number of reconciliations that have occurred, or the length of time that some children had been in the kinship carer before reconciliation:7 children returned to parent/s after 1 or 2 years, 14 children returned after between 3 and 10 years, 3 children returned after more than 10 years

All but two of the kinship carers enjoy ongoing access to the children for whom they cared. Two carers have no access to the child/children they reared, and one carer has since passed away. In two cases the former carer provides occasional care for the child. This allows continuation of the previous close relationship and assists the parents.

KCV takes the opportunity provided by this report to call again for a complete overhaul of the support offered to kinship carers. Increases to carer's allowances and the provision of some special payments for permanent carers, implemented by the current Victorian Government are acknowledged and have been well received by carers. However, kinship care needs to be given a greater range of support.

For the past twelve months KCV has dealt with an increase in complaints made by kinship carers about the way the system treats them. There are general complaints about the way they are spoken to through to very specific complaints about the level of financial support they receive. Particularly noticeable are the complaints about how discretionary funds are decided upon and allocated. Individual child protection case workers seem to make up their own mind in a vacuum about what financial support some children are entitled to. Guidelines within which all child protection workers must engage with kinship carers and make decisions affecting them are needed and should be made know to the carers.

Years after the kinship care support program for Victoria has been in place there are still very many instances where children have been left with carers without any assessment of the needs of the carer and identification of the support they need to perform well their role as kinship carers. Further, there are very few instances of the family group conferencing and family planning promised in 2010 as part of the kinship care support program. Both these measures are a crucial foundation upon which the success of the placements rest.

KCV is stunned by the trend to close cases too quickly and to, in effect, leave the carers to their own devices. Closing cases quickly may reduce the numbers of children/ young people who are deemed to be in out of home care but it does nothing to guarantee the wellbeing of children/young people. The number of carers who call the KCV offices and say that the children/young people have been left with them and the case has been closed without any assessments being undertaken is alarming.

KCV calls on the Minister for Families, Children and Youth Affairs to release the review of kinship care commissioned by the government and undertaken by KPMG. Carers in the KCV Longitudinal Study as well as many other carers not included in the study participated in the focus groups that provided information to the review. They look forward to discussing the report detailing the outcomes of those discussions and being part of a better pathway into the future for kinship care – the fastest growing form of out of home care around the world and the one that keeps children with their family.

Once the adjudicators' rankings have been received by ANPA, the twelve successful applicants will be notified and invited to play in Shepparton in September.
