Where are the women?

The Women's Leadership Institute Australia is based at the University of Melbourne. Carol Schwartz AM Founding Chair of the Women's Leadership Institute, recalls that she had asked a conference of business leaders in 1990 "Where are the women?" In 2015, speaking about the women who are more than half of the graduates in law, medicine, economics and humanities she asked again why high achieving women are not seen on a basis of equality in leadership roles in government, corporate boardrooms, universities and other institutions?

Australia's involvement with the International Council of Women-CIF began 120 years ago, initially in Sydney, and since then NCW Australia and the Councils of Women in the States and Territories have adopted a partnership approach to challenge the barriers that prevent women from having equal opportunity to achieve, advocating more equal participation of men and women in public life and leadership roles, both in Australia and internationally. The Women's Leadership Institute Australia notes Creating equal opportunity for women to reach leadership positions is a complex equation that requires deep cultural change. However as WLIA suggests one element in creating change will be achieving the equal recognition of women in the Australian Honours system.

National Council of Women in Victoria has been attentive to the need to find ways in which attention can be drawn to women's achievement for example through nominations to the Victorian Honour Roll Women's since it began in 2001. The VHRW records the achievements of almost six hundred women leaders whose work had impacted for good in many fields in *Victoria*, Australia & beyond.

As a way of educating our members about ways in the way such achievements could be better recognized,

from 2004-2009, NCW Victoria used its Dame Phyllis Frost Award program identify individuals who had made a significant contribution to the enhancement of the status of women and girls in Victoria, had shown long term commitment to such a cause or causes, and made an especially significant voluntary contribution above and beyond that required in the nominee's employment.

Our July 2016 Council meeting has been designed to enable members to gain a better an understanding of the Australian Honours system with presenter and Melba Group member Jenny Standish. The challenge set out in the Melba Groups Awards Training Program is Aim personally to nominate one woman every year.

<u>Food Standards Australia New Zealand -</u> The latest <u>Notification Circular</u> (16–16) was published on 29 June 2016. The Circular summarises work currently being undertaken or finalised by FSANZ including: **Extension of Use of Propionates in Processed Meat** (Call for submissions), **Irradiation of Blueberries & Raspberries** (Call for submissions), **Extension of Use of L-cysteine as a Food Additive** (Call for submissions), **Addition of Water to facilitate Wine Fermentation** (Call for submissions) **Food derived from Herbicide-tolerant Corn Line MON87419**, **Removal of Country of Origin Labelling Requirements**, **Benzoate & Sulphite Permissions in Food. A Symposium is being held to mark 25 years of food standard-setting**

<u>Australian Institute of Health and Welfare</u> released a new report (with web updates), on 28 June 2016: **Monitoring** *the health impacts of mandatory folic acid and iodine fortification:*

This report assesses the health effects of mandatory folic acid and iodine fortification, introduced to help reduce the prevalence of neural tube defects and address the re-emergence of iodine deficiency in the population. Mandatory fortification resulted in increased levels of folic acid and iodine in the food supply, increased folic acid and iodine intakes, a decreased rate of neural tube defects in Australia, and improved iodine status in the general populations in Australia and New Zealand. <u>Australian Institute of Health and Welfare</u> the web report released on 29 June, 2016 **NFPAC national child protection indicators reporting 2015-16 cycle (SAS VA web),** updates the AIHW's online, dynamic data displays for the indicators under the National Framework for Protecting Australia's Children and the National Standards for Outof-Home Care. It includes the latest child protection data related to substantiations of abuse or neglect and out-ofhome care placements, along with a variety of measures that focus on whether Australia's children and young people are safe and well.Data based on the *Strengths and Difficulties Questionnaire* are included for the first time, showing 10% of young people aged 11-17 years in 2014 had social and emotional wellbeing that was 'of concern'.

HOMELESSNESS From Wendy Rainbird, NCW Australia Habitat Adviser, and ICW Environment Adviser.

Wendy has circulated information about the first anniversary of Canberra's Common Ground scheme working with the homeless. She asks to be informed of similar developments in other parts of Australia. Common Ground Canberra is the national capital's first low-cost supportive housing initiative focused on providing quality tenant outcomes for people who have experienced chronic homelessness. These are people who have been homeless continuously for six months or more, or who have experience multiple episodes of primary homelessness over a 12 month period. They often have substantial barriers to housing stability such as a disability, mental illness or substance misuse disorder. Common Ground Canberra also targets low-income earners who are unable to access other affordable housing options. In Canberra of 20 formerly homeless residents at Common Ground: 9 are now employed, 4 are now studying, and 17 are actively engaged in case management. Common Ground is based on a partnership between Argyle Housing and Northside Community Service. http://www.commongroundcanberra.org.au

This Call for Homelessness to be priority issue by Carmen Green comes from the July Issue of the UAW Newsletter

More than 100,000 Australians are currently homeless and the numbers are rising. They include families, women with children fleeing domestic violence, and people who can no longer sustain private rental because it's getting so expensive. 40% of people who are homeless are under the age of 25. In our wealthy country, this is a national shame!

National Council of Women Victoria Meeting - June 2016: Two speakers from WPI (Women's Property Initiatives) – Caroline Larcher and Kristie Looney gave an interesting overview of this very important organisation. WPI was established in 1996 through a project funded by the Victorian State Government in response to a lack of affordable, appropriate and secure housing for low income single women and single mothers. WPI currently has a housing portfolio of 68 houses and apartments located in several Melbourne suburbs worth over \$20 million. They continue to provide housing for underprivileged women and children and currently house just under 200 tenants. They charge below market rent (no more than 75% of market rent or 30% of household income). The housing chosen must meet the standards set by WPI for suitable housing for the women who will live there. They also have a shared equity housing model whereby women with some savings can be assisted by WPI to buy a house with both having equity. They have also developed a real estate agency the profits of which go back to WPI to purchase additional housing for the many women and children on their waiting list. They are also hoping to get funding from the Andrew's Government's additional \$50 m to house women fleeing from domestic violence in Victoria. They are certainly an innovative organisation. ERA has promoted WPI on its website as providing a suitable model for the campaign across Australia to end the housing crisis by 2025.

By the time (...) members read this article, the Federal Election will have been held and the results known. Tragically, the many calls for homelessness to be made a priority issue in the Federal Election campaign were almost entirely ignored by Australia's political parties. So the campaign to make our politicians take notice of this issue will need to continue until the Federal Government is forced to take action. In the immediate future, homelessness service providers need increased funding and future certainty of both state and federal funding arrangements and the

Federal Government must determine to end the housing crisis by committing to continuing investment in social housing.

Equality Rights Alliance (ERA) has urged its members to support the #Votehome campaign which is led by an alliance of Homelessness Australia and National Shelter. The aim of the Alliance is to get major parties to commit to a national strategy to end the housing crisis by 2025. ERA's promotion of #VoteHome was done through social media and email to member organisations such as the UAW and the NCWA. ERA also used the platform as an opportunity to discuss women's housing issues in the lead up to the election. <u>Vote Home: Let's end the housing crisis by 2025</u> is a change.org movement with about 4000 supporters. There are also accompanying petitions on negative gearing and halving homelessness. To join the movement by signing the petition and circulating it to friends. Barbara Brown, our Convener of Individual Members, is involved in organising the program. There have more than 20 applicants for ANPA this year. The application requirements for ANPA are quite challenging, so only the most capable and experienced young professional pianists apply. Applicants' audition CDs have been sent off to the three adjudicators: Clemens Leske (ANPA first-prize winner and lecturer at Sydney Conservatorium), Rolf Plagge (Mozarteum - Salzburg) and Diana Weekes (Adelaide). Once the adjudicators' rankings have been received by ANPA, the twelve successful applicants will be notified and invited to play in Shepparton in September.
