Children's Matters

The Commission for Children and Young People will soon begin an inquiry into the permanency changes arising from the Children, Youth and Families Amendment (Permanent Care and Other Matters) Act 2014. The changes took effect in March 2016, and the inquiry will examine the evidence available after the first six months of their operation to consider whether the amendments are meeting their objectives of improving permanency for children and young people and whether they have lead to unintended consequences.

At the 17 August Children's Matters Forum, Commissioner Liana Buchanan said: "In just four months as Commissioner I have heard many different views about the impact of the permanency amendments, including some very strong concerns. I am in no doubt this is an important inquiry, and I look forward to reviewing the evidence and hearing from people about their experiences over the past six months. I encourage people who are interested to make a contribution to the process - the more information we have to rely on, the stronger our findings will be."

The inquiry will consider whether the amendments have had any direct impact on outcomes for vulnerable children and families; whether the permanency amendments are

leading timelier permanent outcomes, to including family preservation and family reunification for vulnerable children and for children for whom it is unsafe to return to the care of a parent; whether the permanency amendments have strengthened cultural supports and planning for Aboriginal children in out of home care; what impact, if any, have the permanency amendments had on child protection and other services; whether there have been any unintended consequences directly attributable to the permanency amendments; barriers that prevent permanent care orders being made.

The inquiry will be informed by evidence and data and will involve a number of components including consultations and a submission process. The Commission wants to hear from a range of interested stakeholders about their experience of these amendments. This inquiry will be guided by the best interest principles in section 10 of the Children, Youth and Families Act 2005, the Charter of Human Rights and Responsibilities and the United Nations Convention on the Rights of the Child. The inquiry will commence in September 2016 and be finalised in March 2017. Honorary Life Membership for Betty Spikin

The award of Honorary Life Membership of NCW Victoria will be part of the NCWV AGM on 1 September 2016.

Patricia Betty Spikin Lt. Col. Salvation Army (Retired) has been a long time active member of NCW Victoria, first with NCWV Bendigo Branch in 1987 when as a Salvation Army Officer she was appointed to the Salvation Army Corps in Bendigo. She was Delegate for the Salvation Army in Bendigo, as well as later a delegate for Soroptimist International of Bendigo.

After her transfer to Melbourne in 1991, she became active with NCW Victoria as Delegate for Salvation Army's then Home League, later for the Salvation Army Social Welfare Section in 1996; and the Salvation Army Victoria State Council (2001-02); in all for a further 10 years. It is recalled that in the 1990s when she arranged a NCW Victoria Information Table at an Expo on Ageing conducted at the Royal Exhibition Building. Lt Col. Spikin also served as a Delegate for Soroptimist International Ringwood and Foothills from 1996 – 2004.

During her years as a Delegate she was elected to the NCWV Executive and served several terms 1994 - 96, 2001-02 and 2003-04. She was elected Junior Vice President 1997 and Senior Vice President in 1998-2000. Betty acted for a time as the NCW Victoria contact with the then outside appointed NCWV Public Officer. She was NCW Victoria Public Officer in 2000 (March-May), and served again as Public Officer for 2006-08. Betty's great organisational experience led to her being asked to serve as a member of the Constitution sub-committee early in the 2000's for the March 2002 amendments, and again for the August 2010 Constitutional Review. Above all Betty Spikin's many decades of professional experience in the Social Welfare field means that she continues to make a significant contribution to the NCW Victoria Standing Committees particularly in relation to welfare, housing and ageing issues. Even after the Salvation Army discontinued membership of NCW Victoria, Betty continued her involvement with NCW Victoria as an Individual (Associate) member.

The 2016 'My Vote My Voice – the Right to Vote the Right to Stand' held in the Legislative Council Chamber, Parliament of Victoria on 12 August 2016 was a most successful event with fifty students and guests attending. YoungNCWVic members met school groups and others and ushered them into Queen's Hall for refreshments. President Sheila Byard welcomed VIPs including Helen Coleman, State President Australian Local Government Women's Association (ALGWA Victoria), Dr Debra Towns, Vice-President, League of Women Voters Victoria, Colleen Hartland MLC Western Metropolitan Region, Cr Jennie Mulholland (Banyule) and panel members the Hon. Judy Maddigan, Cr Felicity Frederico (Bayside) and Samantha Dunn MLC Eastern Metropolitan Region.

Margaret Fitzherbert MLC Southern Metropolitan Region, Shadow Parliamentary Secretary for Women's Health and Rural and Regional Health, welcomed us to the Parliament, on behalf of the President of the Legislative Council. A NCWV *Civics and Citizenship Award* honouring the late Jean Cheshire was presented to the Melbourne Girls Grammar team of three who had made an outstanding contribution to the 2015 'My Vote My Voice — Beijing + 20' event. Then there was time for photographs for the students with, with NCWV members, guests and the members of the Australian Local Government Women's Association (ALGWA).

Our 2016 event was designed to encourage students to investigate the level of participation of women in the community, particularly local government, past, present and future. The ALGWA provided copies of 'The Right to Vote; the Right to Stand – the involvement of women in local government in Victoria', for each participating school, to help students in their research. Ms Tina Hosseini, Youth Commissioner, Victorian Multicultural Commission, gave the opening address. Lead student speaker Alicia Ranasinghe, Year 9, Our Lady of Mercy College, Heidelberg, runner-up in the National Legacy Junior Public Speaking competition last year, was the opening speaker, with the theme of "I could be the voice to fill the gap" in the representation of women at all levels of government. She outlined the changing roles of women since the 1900s and quoted significant women who had 'broken the chain' including Mary Rogers, Julie Williams and most recently Jenny Mulholland, who stated during her interview with Alicia, "It is no longer a man's world, it is an equal world". We had speakers from Ruyton Girls' School, Mac Robertson High School, Ivanhoe Girls' Grammar and University High School, with observers from Melbourne Girls' Grammar, and Korowa Girls' College.

Evaluation sheets were completed by panel members (and others) as students were speaking. All students spoke with confidence and appropriate content. It will be difficult to determine award winners. Dr Towns chaired the feedback session, where she and panel members offered comments and advice to the speakers. This was then opened to those attending to add their feedback. A lively discussion followed on whether the use of the term 'Girls' instead of 'Women' is appropriate, citing the commentary from the 2016 Rio Olympics commentary where the talk was about men's teams and girl's teams. A range of views were expressed about the experience of a transition time when one moved from girl to young woman. Sarah Morgan, Youth Adviser thanked those who spoke, panel members and all who had contributed to the event including the VEC. (Pam Hammond, Convenor)

Better Care Victoria arrangements - Information supplied by Nurcihan Ozturk NCWV Adviser Migration Multicultural Affairs

The 2015 Review conducted by former AMA Victoria President Dr Doug Travis of strategies to improve the capacity of Victoria's public hospitals led to the Victorian Government acceptinms all of the recommendations of the Travis Review, including extra patient beds and the development of a Statewide Strategic Services and Infrastructure Plan with a 20 year outlook to address the current mismatch of hospital capacity and infrastructure to patient demand.

<u>Better Care Victoria</u> supported by the <u>Better Care Victoria</u>: <u>Innovation Fund</u>, is to assess initiatives, scale up proven innovations, and facilitate the sharing of ideas to increase hospital capacity across the entire Victorian health system.

As a result of a growing and ageing population there will be increased pressure on the health system. However, Dr Travis found there is a mismatch in some areas between the available capacity of public hospitals and local patient demand.

The first Statewide Strategic Services and Infrastructure Plan will be published in 2017. The Travis Review also recommended greater publication of performance data of hospital and outpatient clinics to drive improvement.

The Department of Health and Human Services in late 2015 published the *Specialist Clinics Activity and Wait Time Report* for the quarter to 30 June 2015, which lists median waiting times for 14 public specialist surgical clinics such as cardiothoracic, ear nose and throat, gastroenterology, gynaecology, neurology, oncology and orthopaedics. It showed there were more than 278,000 specialist clinic consultations delivered by 17 public health services in the quarter. Of these, around 52,000 were new referrals and 226,000 were follow-up appointments. However, the median wait time for a first appointment with an ear, nose and throat specialist at one health service was 469 days, while another was just 31 days showing that Victoria's health services need to work collaboratively to achieve better patient outcomes.
