From the Interim President Elisabeth Newman's report to the July Executive

Thanks to those who assisted with the NCWV tasks during my absence, particularly Mavis Lynch, Sheila Byard and Janet Galley. Following the ICW-CIF Board meeting in Ottawa, Board members were invited to attend the 124th AGM and Conference of the NCW Canada which was interesting.

The NC in Canada operates much as NCW within Australia. There are local branches as well as Provincial Councils which are affiliated to NCW Canada. At the national level, the Council appears to be made up of 3 or 4 differing Committees. The one that took my interest is the Administrative Committee which has members responsible for specific tasks, viz: Archives, Finance (Treasurer) Information and Public Relations, Minutes (AGM)), Media and Website, Resolutions and Nominations. Several resolutions were passed.

With the formation of a new Executive in September we in Victoria need to consider ways of making members responsible for specific tasks, working under the guidance of the President and Secretary, with the aim of making NCWV more efficient and spreading the work load. I thank those who attended the NCWA Mid-Term Conference very ably representing NCWV. We now need to turn our attention to *My Vote My Voice 2017* for which Pam Hammond is Convenor; the AGM preparations and then the end of year lunch and the Pioneer Women's Ceremony. Along the way, however, we need to note the outcomes of the *Future Directions* discussion and look to implement suggestions that will enable NCWV become more efficient as well as visible.

<u>Arrangements for AGM</u> – Time frame for nominations for the AGM includes notice and call for nominations 42 days ahead of the AGM, nominations on the required form with attached bio sheet or CV to the Returning Officer 21 days ahead that is 17 August 2017. Nominees must be paid up members or delegates of organisations that have renewed membership for 2017-18.

<u>Consumer Affairs Victoria</u> - All incorporated associations must use myCAV to lodge annual statements and undertake all transactions and notifications of change. The current secretary (or delegate) uses her own individual myCAV account to use the system, linked to NCWV Inc's incorporated association record. An association must lodge an annual statement every year within one month after its annual general meeting. On or after the association's end of financial year date, CAV emails the association secretary a notification to lodge the annual statement.

<u>Correspondence</u>: By email and Australia Post, including notification from Minister Richardson that the nomination period for Victorian Women's Honour Roll had been extended to Monday 31 July. NCWA sponsored young members from across Australia to attend the Mid-Term conference in Canberra that ran from June 13-16. This year Gauri Kapoor and Sarah Morgan from Victoria attended workshops and the conference on the Wednesday and Thursday on behalf of the Young NCWVic group, with the help of some additional funding from NCWV. The mid- term conference this year had the theme: **Future Directions, our Council, our voice – Driving Cultural Change.** The program was:

Wednesday afternoon – Young NCWA workshop

Frances Crimmins, YWCA, <u>Leadership with integrity</u> - This session focused on self-reflection and our own personal values, concentrating on 4 principles of Self-reflection, Balance, Self-confidence, Genuine humility (values when in a position of responsibility!)

Genevieve Jacobs, ABC morning radio, Canberra - Communication/social media awareness: Local focus, how she got to where she is today, speaking with integrity, truth and honesty, speaking with own voice.

Zoe Ralph,_Author/presenter - The art and practice of Assertiveness: How to present as a confident person, Body language.

<u>Wednesday evening</u> - The after-dinner session was Discovering our Herrmann Brain Dominance Instrument (HBDI), we learnt what part of our brain we preferred to use and also how personality traits link with this preference. <u>Thursday Morning</u> - Breakfast at Parliament House for the official launch of Young National Council of Woman Australia by senator The Hon Michaela Cash (Minister for Women), Meet and group picture with Prime Minister of Australia, The Hon Malcolm Turnbull, Voting on the proposed resolutions.
