Theme: Sustainable and Safe Cities, especially for Women & Girls, focusing on Safe Streets, which reflects the ICW-CIF Theme — "Social protection for all women and girls: Sustainable development for the world" (See flyer page 2) The emphasis of the Forum will be on what makes a Safe City/Safe Streets — wide streets, pedestrian malls, good visibility, good lighting and signage, good public transport etc. Everything that ought to come under good planning.

From the President, Elisabeth Newman:

The year is racing by, so it seems, at an alarming rate and with the NCWV year ending in a little over two months, viz. 30th June, it means report time, reflection on what has been achieved during the year and what we aspire to for the forthcoming year. It also, importantly, means thought needs to be given to succession planning. Over the next few months I urge every member, whatever your category of membership, to give serious thought as to who you would like to see on the Executive so you are ready for when nominations are called. For information on any of the positions please contact myself or any member of the Executive. New blood/fresh ideas are vital for the ongoing work and survival of NCWV. There is much to be done in ending discrimination, including violence against women and girls, and gaining gender equality; then we can have true peace with respect for all. Since the last newsletter we have celebrated International Women's Day, a time when we reflect on achievements, but on what also needs to be done to gain universal gender equality and peace.

In March I was in NY to attend the 63rd Commission on the Status of Women (CSW63) as a member of the ICW-CIF delegation and, as a Director, to attend the annual meeting of Project Five-O. ICW-CIF held a side event as well as a parallel event and Project Five-O ran a seminar (ex CSW) based on Sustainable Development Goal 3 (SDG3). It was an honour to have Robyn Nolan, President of NCWA, as one of the two NGO representatives in the Australian Government delegation. The Australians did a great job, along with the NZ, Canadian, UK and a few other like-minded delegations to keep the negotiations on

the Agreed Conclusions focused, despite a strong undercurrent from the minority conservative group who disagree with women having certain rights. The Australians also had an active support team outside the negotiation room who were terrific. A Consensus on the Outcome Document (Agreed Conclusions) was reached but not without some controversy.

At the request of Dr Jung Sook Kim, President of ICW-CIF, and the Board, Hean Bee Wee and I have been co-opted onto the Board for this Triennium due to our knowledge in certain areas; Hean Bee for certain financial issues and I for Standing Committees. I was bidden to attend the Board meeting held in NY. Although not required, as these are co-opted positions, we thank the NCWV Executive for their unanimous support, also that of the NCWA Board.

March Council Meeting was our first in the late afternoon to accommodate students and those in work. Being the eve of IWD the chosen speaker, Dr Marissa Parrot, reflected strong, professional and inspiring women.



Dr Marissa Parrot, Reproductive Biologist, Wildlife Conservation & Science, at Zoos Victoria, her topic was: Zoos Victoria, Fightina Extinction. The major focus of Marissa's research is captive breeding, reintroduction and conservation of some of Australia's most critically endangered species. Marissa works across Werribee Open Range Zoo, Healesville Sanctuary, Melbourne Zoo and a variety of field locations to improve threatened species reintroduction and captive breeding success, and leads reproductive and behavioural research projects. She has 18 years experience in wildlife field work, five years in molecular genetics laboratories, 14 years in captive breeding programs and has been involved in a variety of wildlife and conservation programs across Australia, Asia, Africa and the Americas. Marissa has been named as an Australian Science Hero by the Australian Office of the Chief Scientist, a Global Wildlife Talent by National Geographic, and is a member of Homeward Bound, a global leadership initiative for women in STEM set in Antarctica. There are 95 women from 35 countries involved in 2019.

Marissa is part of a number of Threatened Species Recovery Teams with a strong focus on endangered native marsupial, rodent and frog species to aid Zoos Victoria's commitment that no Victorian terrestrial vertebrate species will go extinct. This focus was heightened when the last Christmas Island bat died when she was there. There are 17 Victorian, 4 regional species at severe risk that Zoos Vic are working with in captive and breeding programs, aimed at release and having them survive in the wild. Information and great photos at: https://www.zoo.org.au/fighting-extinction Strategies used vary between species, including selection of mates to optimise health and diversity of offspring, analysing hormone cycles to increase fertility, replicating environments and predator avoidance.

There are also International Conservation programs that Marissa's team is involved in, including the <u>Rhino Fund Uganda</u>; <u>Philippines Crocodile Recovery</u>; <u>Tree Kangaroo Conservation Program - Papua New Guinea</u> and others.

Zoos Victoria is fighting extinction from the ground up with grass-roots community conservation campaigns. The aim is to inspire the millions of Zoo visitors and the wider community to take simple actions that will help wildlife and wild places all over the world, including: Donate old mobile phones, to be recycled and reduce the need for coltan mining conducted in Gorilla territory; Use recycled toilet paper to protect forests; Fight for mandatory labelling of palm oil on products so that consumers can choose responsibly; Balloons to reduce their ingestion by marine life. Simple choices can make a real difference. Everyone can do their part to fight extinction and save the environment. Marissa is also involved in mentoring and training here and internationally, one being in Cambodia on capacity building at the Royal University in Phnom Penh after Pol Pot genocide. On the eve of IWD she showed photos of the strong women working in her team at Zoos Victoria, other women include the Chair of the Board, CEO, Director of Melb Zoo, Veterinary Scientists, Animal Trainer, Animal Welfare Specialist, Zoo keepers and Researchers.

Marissa's path to her current position was a Science degree, then masters in genetics studying the feather glider, finding a tiny antechinus that was its predator. Antechinuses have a short, violent breeding season, after which males die. Her PhD was on partner selection developing a test for compatibility, finding mates were chosen for differences. She did volunteering locally and internationally, then at Healesville where she was offered a position.

Clarendon Terrace, once home to the Menzies Foundation, has recently been reinvented as Her Place Women's Museum which is a not-for-profit organisation that celebrates the social, civic and entrepreneurial achievements of all Australian women and their role in shaping our nation.
