For 2020/21, we were fortunate that many advisers and committee members were continuing - familiar with the NCWV principles and practices - joined by inquisitive new members with different knowledge and skills. At this AGM, both our Immediate Past President, Elisabeth Newman AM; and our Communication Adviser, Mass Media (also National Co-ordinator Communications) May Hu OAM JP, will step aside, leaving a considerable gap for us to fill – along with the vacant role of Honorary Secretary.

NCWV Annual General Meeting, 2nd September



Dr. Lois Peeler AM, of Yorta Yorta and Wiradjuri heritage through her mother and Wurundjeri heritage through her father, will speak prior to the AGM at 12:15pm. She is Executive Director Principal οf Worawa Aboriginal College, the only boarding school in Australia catering specifically for young Aboriginal women. She was one of the members of The Sapphires, and is Australia's first Aboriginal model and TV presenter.

She is committed to the education and preservation of Victorian Aboriginal history and culture. As Principal of Victoria's only Aboriginal school, the pedagogy is based on learning from the land and Aboriginal Ways of Knowing, Doing and Being. She is currently involved in developing an Aboriginal Resource Centre focused on Victorian Aboriginal history, culture and achievements.

Individual Members Annual Meeting

This was conducted at 11:00 am prior to the Council meeting, on August 5th, followed by Individual member Wendy Le Get talking about the sale of the family property in Western Australia which her Grandparents took up as virgin country in 1906. There was a large collection of old machinery and household items as well as buildings, all well preserved. The local Heritage group and Local Council have set up the "Koobabbie Precinct" in Coorow W.A. where a collection of these items are displayed, including three of the smaller original farm buildings that could be moved. To learn more Wendy says google "Koobabbie". This was a most fascinating talk, with members being amazed at the work Wendy put in to finally complete this project, highly respecting the family legacy and donating part of the property for conservation.

At the election Elisabeth Newman AM was elected as Convenor; Beverley Kannegiesser as Book keeper and IM representative on Committee; Carol Robertson as Notetaker; Deputy Convenor position is vacant.

August Speaker



Sandra Buckley, CEO of Women in Super, not-fornational profit networking and advocacy organisation for women employed in superannuation and the aligned financial industry. services Founded in 1994, WIS has a long history of advocating for better retirement outcomes for women.

With over 2,500 members across Australia, WIS was formally established in 1994 to provide networking opportunities for women working in the profit-to-member superannuation and associated financial services sector. Since then, it has developed into a national organisation with committees in every state and territory (except the Northern Territory) with a Mission to work towards a superannuation system without gender-based inequity. WIS works to

- make super fair by improving women's retirement outcomes through policy change;
- provide opportunities for members to develop their networks and professional development training;
- promote equal participation of women at all levels within superannuation and financial services industry;
 strengthen the WIS network through promotion of the
- Mother's Day Classic, initiated by WIS in 1998, raising \$33.2mill for the National Breast Cancer Foundation! Since joining WIS in 2014 Sandra has led the strategy, advocacy, policy, research and campaign work that WIS undertakes to improve retirement outcomes for women. WIS led the campaign to 'Save the LISC' (Low Income Super Tax Offset) preventing negative impact on balances of 1 in 2 working women who earn \$40,000 or less. Sandra quoted data on women superannuation issues, including the gender pay gap which on average is 17%; more casual or part time work, so may not reach the \$450 threshold for super and if they do, may be in multiple super funds with fees, also super was voluntary until the 80s, so many women have insufficient (or no) super on retirement. COVID has exacerpated this. The release of super funds was taken up by many women aged 25-34 years, reducing their retirement funds.

Sandra believes that education on types of super funds, strategy/risk profiles, fees, contribution policies etc. essential, even included in the school curriculum. More women are now on Super Boards, as CEOs and CIOs.

WIS' vision is a superannuation system without gender bias, working with industry, government, employers and universities to affect policy change and raise awareness of issues facing women in accessing super. Sandra Buckley was appointed to the Australian Gender Equity Council board in July 2019 and as Deputy Chair in November 2020.

VALE: Diane Berenice Alley (Duke) OBE (1927 - 2021)



Diane Alley has worked consistently for over five decades to promote the principles set out in the Universal Declaration Human Rights. She was Honorary Secretary of the NCWV 1968–1975, president 1976, President 1977–1980, then President NCWA 1982-1985 Convenor of the Child and Family Committee at State, National and International Council levels.

In 1986 she became Honorary Life Member of NCWV; and Honorary Life Vice-President of NCWA.

Diane worked through Councils and other organisations, in order to ensure equal opportunity for women and achieve social justice for all members of the community, both in Australia and internationally, including the National Status of Women Committee, United Nations Association of Australia (UNAA). She received the UNAA Founders Award in recognition of her lifelong dedication to women's rights and social justice

She was appointed Officer of the Order of the British Empire, 1981 for community work and among the first women admitted to the Victorian Women's Honour Roll in 2001. Both state and national governments appointed her to advisory bodies: the Victorian Premier's Equal Opportunity Advisory Council 1978–1982 and the National Women's Consultative Council 1984–1986.

Dame Ada Norris selected Diane to succeed her as Chair of the National Status of Women Committee, United Nations Association of Australia (UNAA) 1980, becoming Vice-President in 1984. She convened the committee for the UN International Year of the Child 1979, and was Patron of the UN International Year of the Family 1994. She received the UNAA Founders Award in 2007.

Diane was Chair of the Victorian Consultative Council of Social Development (1985–1986), on its Family Policy Sub-committee from 1979 and National Advisory Council on Social Welfare (1983–1985). She was an honorary magistrate of the Children's Court 1972 - 1984, executive member of the Free Kindergarten Union 1960–1975 and Vice-president of the Children's Protection Society from 1980. She provided support for the Victorian Immigrant and Refugee Women's Coalition.

She served on the Fairlea Women's Prison Council 1979–1983, and was an official prison visitor to Pentridge and Fairlea. To equip herself for these roles, she undertook a Diploma of Criminology (Melb).



INVESTMENT BOOST FOR WOMEN'S STARTUPS

Women in the startup sector are a step closer to having their business dreams realised, with applications opened for a new fund which will drive early-stage investment. The Andrews Labor Government's Alice Anderson Fund will co-invest \$10 million in early-stage capital for up to 60 women-led startups. With every dollar of Government funding to be matched by three dollars of private investment, the Fund could unlock up to \$40 million to drive early-stage startups. Led by startup agency LaunchVic, the Fund will see the Government co-invest between \$50,000 and \$300,000 for new businesses.

The initiative will help women-led business overcome funding hurdles – a 2019 study revealed only 19 of 104 Victorian startups that received angel or venture capitalist investment had a woman as founder. The Fund is open to local and international angel networks, early-stage venture capitalists focused on seed investments, family offices and individuals.

Nominated startups for co-investment must be 50 per cent owned by at least one woman, or have a 30 per cent ownership stake by women, including one woman in an executive role. If there is a board, it must have representation of at least 30 per cent women. The Fund is named in honour of Alice Anderson, a pioneering Victorian mechanic and entrepreneur who founded Australia's first all-women motor garage in Kew in 1919. Victorian Royal Commission into Family Violence

The following data shows progress since the Victorian Royal Commission handed down its findings in 2016.

- > Over 1,500 Victorian schools signed on to implement Respectful Relationships 2017-2020;
- > 25,000 information requests under Family Violence Information Sharing (by key areas of government);
- > 3,453 reports by Central Information Point;
- > Seven perpetrator interventions available for diverse cohorts; Men's Behaviour Change Programs available in Arabic, Vietnamese, Mandarin, as well as English;
- > 10,553 workers trained using the Family Violence Multi-Agency Risk Assessment Management (MARAM)
- > Framework and the Family Violence Information Sharing Scheme in 2019-20.

Major achievements during monitoring period:

- > 23 recommendations implemented (bringing the total implemented to 166);
- > delivery of multiple primary prevention campaigns, including Respect Each Other: 'Call It Out', May 2020
- > release of the first Gender Equality Baseline Report in November 2019
- > statewide rollout of the Family Violence Intervention Order online application form in the Magistrates' Court of Victoria in June 2020
- > opening of Ballarat Specialist Family Violence Court Nov. 2019
- > commencing Moorabbin Magistrates' Court as a Specialist Family Violence Court in 2020
- > opening of The Orange Door in the Central Highlands and Loddon areas in October 2020
- > enactment of the *Gender Equality Act 2020* in February 2020 and establishment of the Public Sector Gender Equality Commissioner
- > articulation of a whole of Victorian Government perpetrator accountability work program in October 2020, including a redeveloped perpetrator outcome domain of the Family Violence Outcomes Framework.
